Mission

Objectives

- To enhance efforts to conserve the numbat and its natural habitat.
- To assist the Numbat Recovery Team with conservation activities including research and reintroduction programs.
- To assist in the protection and restoration of current and former numbat habitat.
- To promote and assist landholder participation in feral animal control programs, in cooperation with the relevant Government Agencies.
- To promote and assist community awareness of the numbat and the need to support its recovery via the media, schools, local shows etc.
- Develop collaborations with other community organizations and action groups with similar objectives to pool resources to achieve identified outcomes.
- To undertake fundraising activities to support numbat conservation.
- Undertaking education and community awareness programs promoting the significance of the numbat and its habitat.
- Supporting on-ground work that directly assists the conservation of the numbat and its associated habitat.
- To establish and maintain a public fund to be called the Numbat Conservation Fund for the specific purpose of supporting the objectives of Project Numbat. The fund is established to receive all gifts of money or property for this purpose and any money received because of such gifts must be credited to its bank account. The Numbat Conservation Fund must not receive any other money or property into its account and it must comply with subdivision 30-E of the Income Tax Assessment Act 1997.

Support for the Department of Parks and Wildlife

In the 2012-13 financial year, Project Numbat provided The Department of Parks and Wildlife with \$4750 for radio tracking collars. This money was raised by donations from members at \$250 per collar. Donors received a certificate of their collared Numbat with information about the animal's name, date of birth, weight, sex and release location.

Eleven collars were fitted to numbats that were bred at Perth Zoo and released into the Australian Wildlife Conservancy's Scotia Sanctuary in New South Wales, while the remaining collars were used on wild caught numbats in monitored populations in Western Australia. Due to the success of this fundraiser, it is being run again in 2013 for the release of numbats in December 2013

Project Numbat completed the purchase of ten camera traps for the Department of Parks and Wildlife's use in Dryandra Woodland. The cameras will support survey work to elucidate the status of all known populations and this will be written up in a paper on the status and distribution of the numbat.

The cameras will also be used in studies of feral predators (particularly cats) at Dryandra which will assist in the design of an integrated feral predator control regime. The cost of the cameras was approximately \$7000 and this was funded through donations and fundraising.

Education program

Project Numbat presenters Vicki Power and Rosemary Johnston were busy this financial year in delivering presentations to primary schools around Perth. These visits included a presentation to more than 100 students at Rostrata Primary School. The Quiz on Legs event at Kings Park saw more than 1600 school students educated about the numbat. A very successful and busy day indeed!

A number of students have emailed Project Numbat throughout the year, requesting assistance with school projects on the numbat and its conservation. Most students have been from interstate or overseas. It is great to know that our message is reaching all parts of the world!

The primary school education program continues to be downloaded from our website by interested teachers (another 6 times this financial year). Members of the Project Numbat committee have also commenced planning for a secondary school package.

We have also had a numbat taxidermied for our use when visiting schools etc, as well as a numbat costume made which has been used at a number of events throughout the year and is a great hit with children.

Articles about the numbat have been published in two magazines this year – SCIOS (Science teachers' magazine) and Land for Wildlife. It's great to have so much interest in the numbat's plight and hopefully this will help to make the wider community more aware.

Events

Project Numbat volunteers have attended a number of events during the year, including Quiz on Legs at Kings Park, two fundraising bbqs at Rostrata Primary School, a numbat surveying weekend at Boyagin, a numbat fundraiser day in Fremantle run by Lisa Hills, the W.A. Museum's Love Your Local Wildlife program (run over three days) and the City of Belmont's Autumn River Festival.

Fundraising

Project Numbat was fortunate to be the recipient of the Australasian Society of Zoo Keeping's fundraiser held in March 2012, with \$4700 received from this event in October 2012. Thanks go out to ASZK. This money was given to the Department of Parks and Wildlife to be used for predator DNA work, which will be used to further develop predator control research.

Rostrata Primary School again held two fundraising barbecues for us in October and December 2012 which were a great success, raising more than \$1000 in total. This is the fifth year they have held these fundraisers and we look forward to continuing again in 2013. Thank you Rostrata Primary School!

Perth Advocates for the Earth Inc. held a quiz night in January 2013 and generously distributed the proceeds from this event to Project Numbat and the W.A. Dingo Association. We were fortunate to receive a total of \$2020. A big thank you to Leanne Kelman for attending and giving a presentation at this event and of course to Perth Advocates for the Earth Inc. for their generosity!

Memberships

Memberships remained steady over the financial year with a slight increase from 156 at the end of June 2012 to 159 at the end of June 2013.

Online

Project Numbat's website continues to share information on news and activities and is visted regularly. Our Facebook page now has 1221 fans, a great achievement (up from 846 last year). It is helping to spread our message, and generates great interest from each post.

Numbat Conservation Fund

Project Numbat operates the Numbat Conservation Fund which is responsible for receiving donations and distributing them to projects that support our objectives. In 2012-13, we distributed \$4750 in funds to the Department of Parks and Wildlife for numbat radio-collars and approximately \$7000 for the purchase of camera traps.
